1. Question paper packets covering the entire examination schedule will be sent to centers in batches which will be delivered at the concerned examination centers by the University personnel.
2. For some of the examination centres, the University will appoint an External Additional Chief Superintendent apart from one Chief Superintendent from the colleges concerned.
3. Each examination centre should have necessarily provides a strong room/exclusive steel almirahs for keeping question papers in safe custody. 


