



FORM OF AGREEMENT EXECUTED BY PATRICIAN COLLEGE OF ARTS AND SCIENCE MANAGEMENT IN RESPECT OF APPOINTMENT OF TEACHERS

Agreement made this <u>SIXTH</u> day of <u>JUNE</u> Two Thousand Twelve between the College Committee of Patrician College of Arts and Science of the One Part and <u>Mr. Vijay</u> <u>Kumar</u>. V (Teacher) of other part:

Whereas, the Management has agreed to engage the said Mr./Me. Vijay Kumar.V. hereinafter referred to as the said teacher to serve in the Patrician College of Arts and Science, Adyar, Chennai - 600 020. In the capacity of a teacher and on the pay and allowance hereinafter mentioned.

Now these witness and the parties herein do hereby agree as follows:

- 1. That the Management shall employ the said Teacher as a <u>lecturer</u> in the Patrician College of Arts and Science, Adyar, Chennai 600 020 from the date of his/her taking charge of such appointment until such employment is determined as hereinafter provided. You are expected to submit all your original certificates on receiving the appointment order.

- (iii) Recovery from pay to the extent necessary of the monetary value equivalent to the amount of increments ordered to be withheld where such an order cannot be given effect to.

Entries shall be made in the service register of the said teacher only in respect of penalties other than censure. Such entries shall be made only after the appeal, if any preferred by the said teacher is disposed of by the competent appellate authorities specified in the rules.

9. That the said teacher shall be paid a sum of Rs. 9025/- per mensum in the with effect from Consolidated Such teacher shall be entitled to increment indicated in the said scale of pay of Rs.

scale.
