



Greetings from Arunodhaya and Patrician College of Arts and Science!

It has been more than twenty five years since the adoption of the United Nations Convention on the Rights of the Child but still we are very far away from realizing the rights of children. With Child participation as a core principle, UNCRC portrays children as active agents with ability to influence the direction of social change to create a more just social and economic order, nationally and internationally. This means that children should gain space that is legally protected and systematic wherein children can make their contribution to decisions taken concerning them. One of the most effective ways to ensure the participation of children in these processes is to formalize links between children and decision-makers. The concept of participation emphasizes that including children should not only be a momentary act, but the starting point for an intense exchange between children and adults on the development of policies, programmes and measures in all relevant context of children's lives.

Children Nagara Sabai is formed as the structure, wherein children associate at local (Ward) level, deliberate on issues concerning their development and present their opinion and concerns to the elected representatives (Councilars). From the Ward level, children representation should flow to the Zonal and Corporation level, wherein Children representatives would gain space to interact in the Corporation Council meetings. This structure of Children nagara sabai need to have the sanction of government authority to make it meaningful and effective.

The objective of the Consultation is to develop an understanding on Children Nagara sabai and deliberate on ways of advocacy with the Government and campaign on issuing a government order for formation of Children nagar sabai. Issuing a Government order will give legal recognition to the Children Nagar sabai and the children will have the mandate to participate in the decision making process of developing policies and programmes related to Children.

A photographs exhibition 'Child rights through Children's lens' a collection of photographs taken by children will be exhibited

A video documentary on Children nagara sabai titiled "Ullatchi Amaipil Kuzanthaigalin Pangerpu' depicting the process of children nagara sabai and their achievements in the past year will be released.

The invitation and programme schedule is enclosed for further reference.

We request you to kindly depute a senior reporter to participate in the Consultation and report it in your esteemed newspaper/journal/channel and support the cause of ensuring child rights.


